It is my pleasure to inform you that you have been awarded the California Western School of Law (CWSL) Admissions Scholarship. This scholarship will cover % of your tuition for the first year of law school. Additionally, you may be eligible for an academic merit scholarship in the second and third years of law school based on your academic performance and rank among eligible students<sup>1</sup> at the completion of the first and second years of law school, respectively. These scholarships are awarded at the start of the second and third years of law school as follows:

Rank of eligible students based on only first year or second year GPA	Scholarship award for only second year or third year, as applicable
Top 10.00%	100% tuition coverage
Top 10.01%-20.00%	70% tuition coverage
Top 20.01%-30.00%	40% tuition coverage
Top 30.01%-40.00%	10% tuition coverage

Scholarships are subject to the following terms and conditions:

- Students are classified as second year students upon the completion of 27 units.
- II. Students are classified as third year students upon the completion of 57 units.
- III. In order to be eligible for a scholarship in the third year, students must have 1) completed the second year in three or fewer trimesters, and 2) taken during their second year at least four required or California bar-tested courses of three or more credits, not including STEPPS.
- IV. In the event that scholarship recipients transfer from CWSL at any time, they will no longer be eligible for the scholarship and must repay to CWSL the total value of the scholarship awarded up to that point. Students must repay the amount in full within 30 days of the date of transfer. Students may apply for a loan offered by CWSL to help repay the amount. Generally, all loans will be approved upon completion of required documentation. The conditions of this loan and the applicable interest rates are available for review in the CWSL Business Office.
- V. Students who receive scholarships in the second or third year must take the California bar exam before taking the bar exam of any other jurisdiction, unless they request a waiver that is approved by the Vice Dean for Academic Affairs.
- VI. If students are found guilty of an honor code violation, scholarships may be revoked and might not be reinstated.
- VII. Scholarships only apply towards classes taken at CWSL.

If you wish to accept this award for the first year of law school, please confirm by submitting a non-refundable \$500.00 deposit by 04/15/2020. By submitting your deposit, you agree to the terms and conditions set forth above. Your student identification number, which you will need to access this site, is <a href="Upon your enrollment">Upon your enrollment</a>, your deposit (less \$75.00 Student Bar Association fee) will be applied to your first trimester's tuition and fees. If you do not enroll, the deposit will not be refunded.
